- New sustainable processes
- New machinery concepts for sustainability
- Model-based engineering for sustainability

How to participate?

1. On-line registration process

First, you must register at the website. It must be completed all required fields in relation to the organization interested in attending to the event specifying the person/s who would attend to the event.

Secondly, it must be completed the cooperation profile, so that every organization registered their interest or ideas for cooperation in the framework of EUREKA PRO-FACTORY PLUS.

Deadline for registration and profile submissions: September 15th, 2011

2. Meetings

Once the organization has made its registration and created its profile, can consult profiles catalog and if it is interested in a particular cooperation profile may request an interview with the company that introduced this profile. Any organization can request meetings whether they have active profiles in the catalog or not, but it is compulsory to have been registered previously. It is also possible request meetings with national representatives of PRO-FACTORY PLUS.

Deadline for interviews request: September, 26-30th, 2011

Requests for interviews should be confirmed by both parties so that they can carry out the agendas.

Each participant will receive a personalized schedule with its interviews before the meeting. Each Meeting will last for a maximum of 30 minutes.
